- * Areas covered by Category A Intermediate Period Act as defined by ss.232A and ss.232B of the Native Title Act (1993) (C'th);
- * Exclusive Possession is not claimed over areas which are subject to valid Previous Non-Exclusive Possession Acts;
- * areas over which native title has otherwise been extinguished.
